#### LANET PROVIDING INTERNET OPTIONS

Internet options in Sierra los Pinos have been mostly limited to satellite providers until now. Los Alamos Network (LaNet) is in the process of bringing high-speed internet service to our community. They are currently in the process of connecting homes with line-of-sight to their antenna. Those who have been connected are reporting good speeds and reliable service. #### TRACKING WATER USAGE



SLPPOA's water metering system not only measures the amount of water each household uses, it has the ability to alert us to potential leaks at that household. Once the monthly report has been taken and reviewed, SLPPOA water operator. John Hines, will contact anyone with a leak flag.

While it is the homeowner's responsibility to correct any leaks occurring between the meter and the home, as well as inside the home, Hines can assist in locating the leaks. Hines has been working with homeowners for the past six months and your efforts, along with his assistance, have resulted in a significant drop in leakage in our water system!

Every SLPPOA homeowner has the ability to access their water usage on the SLPPOA website at *slppoa.org*. To determine a property's individual water usage, first determine your water meter endpoint #. If you look at your water meter, the endpoint # should be stamped on top of the transmitter and on a tag hanging from the transmitter wire. Use caution around the transmitter wire for your meter as it can be easily broken.

If you have trouble determining your endpoint #, contact John at water1@slppoa.org, for assistance.

Then, take that endpoint # and go to the slppoa.org website and log into your account. Click on the tab "Water" and then the sub-tab "Usage," bringing up the "Anonymous Usage Reports" for each month. To find the amount of water being used per month at your residence, you would then locate your endpoint # number on the list. Meters are typically read on or about the first day of every month and the usage numbers are posted monthly.

### ARCHITECTURAL CONTROL COMMITTEE **SEEKING A VOLUNTEER**

The architectural control committee is looking for one additional volunteer to join them. Duties include reviewing member-submitted applications to determine whether the proposed structure is a good architectural fit for the community.
